This has reference to the email dated 19/01/2024, on the subject cited above. In this connection, it is to inform you that the officer concerned of this department inspected the said premises on 26/02/2024 in the presence of Mr. Vivek Gupta (JE/Elect). During the course of inspection, the shortcomings observed are as below.

- ✓ 1. The first aid hose-reel found provided but non-functional.
2. Automatic fire detectors found provided but non-functional at some places.
3. MOEFA/MCPs found provided but non-functional at some places.
4. The fire pumps found removed/under repair (Common Pump Room).
5. Fireman's switch found defective/non-functional.
- ✓ 6. Lift signage found removed.
7. Lots of waste material/old furniture found lying at terrace, which is hazardous from fire safety point of view.

In view of the above, the application for renewal of Fire Safety Certificate is rejected. You are requested to rectify the shortcomings under intimation to this department for further consideration in the matter.
