F6/DFS/MS/2506/2013/2457 dated 25/10/2013 (copy enclosed).

In view of above, the application for issuance of Fire Safety Certificate is rejected. The occupancy of the building / premises in absence of requisite fire safety arrangements shall be at the risk and liability of the owner / occupier.



Regarding issue of "Fire Safety Certificate" from fire safety point of view in r/o Tirupati Sub: Stone Centre, Urology & Laproscopy Hospital, 6, Gagan Vihar, (Near Karkari More Flyover), Delhi-51.

Sir,

Please refer to your letter dated 12.09.13 on the subject cited above. In this connection this is to inform you that officer concerned of this department inspected the premises to verify the fire safety arrangements in accordance with the Rule 33 of the Delhi Fire Service Rules, 2010. At the time of inspection Dr. Ajay Aggarwal, (MS) was present and it was observed that the premises is comprised of basement ground plus three upper floors has following

- 1. The width of staircases is 1 m as against the requirement of 2 m.
- 2. Fire pump having 900 LPM out put is required in place of 450 LPM out put.
- 3. Over head water storage tank capacity 25,000 liters is required exclusively for firefighting in place 15,000 liters.
- 4. Lift in the basement made to be segregated by providing lobby plus fire check door or be pressurized.

In view of above, the fire safety certificate cannot be issued. Therefore you are suggested to rectify the above said shortcoming under the intimation to this department for further course of action.
