 Smoke management system in basement found nonfunctional and not integrated with alarm system also.

In view of above shortcomings, request for renewal of fire NOC is rejected. The occupancy of building /premises, in absence requisite fire & life safety arrangements, shall be at the risk and liability of the owner/occupier. The statuary/licensing authority may take suitable action as deemed fit.
