You are directed to comply all the shortcomings under intimation with this department for further consideration in the matter. The occupancy of the building premises without valid Fire Safety Certificate is on the risk and responsibility of the management committee

In this connection it is to inform to you that the above said premises was re-inspected by the officer concerned of this department on 29/08/2023 in the presence of: Mr Shambhu Chaudhary (Security Supervisor) from fire safety point of view.

## During the course of inspection followings shortcoming have been observed:-

- 1. Hose Reels & Hydrants system found nonfunctional.
- 2. PA system found nonfunctional.
- 3. MOEFA found Non functional.
- 4. All the Pumps at terrace level found nonfunctional.
- 5. Pumps at Ground level are not scene during inspection.
- 6. Exit signage found removed at some places.
- 7. Communication system in lift car found provided but nonfunctional.

You are requested to comply the abovementioned shortcomings under intimation to this department.

In view of the above shortcomings Fire Safety Certificate cannot be considered at this stage.
