In this connection it is to inform to you that the above said premises was inspected by the officer concerned of this department on 11/05/2024 in the presence of Mr. Manoj Kumar (Manager) During the course of inspection followings shortcoming have been observed:-

1. The internal road around the building found encroached / blocked.
2. MOEFA & PA system found nonfunctional.
3. Fire pumps at terrace level found nonfunctional in auto mode.
4. Exit signage's found removed at some places.
5. Communication system in lift car found removed
6. Hoses and branches found missing at some places.

In view of the above shortcomings renewal of Fire Safety Certificate from fire safety point of view cannot be considered at this stage. You are directed to comply the shortcomings under intimation to this department for further consideration in the matter.

Further the occupancy of the building premises without valid Fire Safety Certificate is on the risk and responsibility of the management committee.
