Sir,

This is in reference to your letter No. nil dated 03.03.2023 on the subject cited above. In this connection, it is to inform you that the school building was inspected by the officer concerned of this department in the presence of Sh. Parveen Sethi, Principal, on 12.04.2023 to check the status of the fire safety arrangements already provided in the school building. The school building was issued fire safety certificate for ground plus two upper floors vide this office letter No. F.6/DFS/MS/School/2015/WZ/995 dated 10.06.2015.

During the course of inspection, it was observed that the school management has constructed one more upper floor and now the school is running at ground plus three upper floors. You are advised to submit sanctioned building plan for 3rd floor marked with required fire safety measures stipulated in NBC-IV/ UBBL-2016, till such time fire safety certificate cannot be renewed/ granted at this stage & rejected.

You are advised to rectify the above mentioned shortcomings under intimation to this department.
