Subject: - Renewal Fire Safety Certificate in r/o National Agriculture Science Complex Pusa, New Delhi-110012.

Sir,

This is in reference to your letter No. DB(10)/ED-XI/2019-20/185 dated 11.6.2019 on the subject cited above. In this connection it is to inform you that the above said buildings/complex has been inspected by the officer concerned of this department from fire safety point of view on 18.7.2019 in presence of Sh. Sunul Kumar Sinha AE (E) & Sh. Sanjay Kumar JE (E) CPWD.

During the course of inspection the following shortcomings have been observed:-

1. Some of First hose reels found non functional & jammed.
2. Automatic sprinkler system is provided in basement of all blocks, but found removed in upper floors of the Symposium/Auditorium Block.
3. Internal hydrants are provided but boxes, RRL Hose, Branch with Nozzle found missing.
4. Hose boxes of some Yard Hydrants are missing.
5. Main Fire pumps not found on auto mode due to leakage/renovation works in pipeline.
6. Pressurization in lift shafts found removed.

In view of the above shortcomings fire safety Certificate cannot be renewed at this stage. You are advised to rectify the above said shortcomings under intimation to this department for taking further necessary action.
