
**NOTIFICATION**

**No.F.1 (11)/2010/DC/MC** In exercise of the powers conferred by subsections (1) and (4) of section 8 of the Hindu Marriage Act, 1955 (25 of 1955) read with Government of India Ministry of Law, Notification No.SRO 2063 dated the 19<sup>th</sup> September, 1955, the Lt. Governor of the National Capital Territory of Delhi hereby, makes the following rules to further amend the Hindu Marriage Registration Rules, 1956, namely:-

**RULES**

1. Short title and commencement – (1) these rules may be called the Delhi Hindu Marriage Registration (Amendment) Rules, 2010  
(2) They shall come into force on the date of their publication in the Delhi Gazette.
2. Amendment of Form A. In the Delhi Hindu Marriage Registration Rules, 1956, in Form A, in clause 7, for sub-clause (vi), the following sub-clause shall be substituted, namely:-  
“(vi) One of the parties or his/her parent is residing within the jurisdiction of the Registrar for more than thirty days  
Provided that in case marriage is solemnized in Delhi, the condition of this sub clause shall not apply.
