NOTIFICATION

No.F.10(2)/Fin.(T&E)/2008-09/ - In exercise of the powers conferred under section 58 of the Punjab Excise Act, 1914 (Punjab Act 1 of 1914) as extended to the National Capital Territory of Delhi, the Lieutenant Governor of the National Capital Territory of Delhi is pleased to make the following rules further to amend the Delhi Liquor Licence Rules, 1976 and since it is considered that they should be brought into force at once, he is further pleased to direct that they shall come into force without previous publication, namely:-

Short title and commencement. 1. (1) These rules may be called the Delhi Liquor Licence (Second Amendment) Rules, 2008.
(2) They shall come into force with immediate effect.

Amendment of rule 26. 2. In the Delhi Liquor Licence Rules, 1976, in rule 26, in sub-rule (2a), for clause (iv), the following clause shall be substituted namely:-

“(iv) Vend fee for IMFL/Beer shall be charged at the following rates at the time of issue of the Import Permit to L-7 licence holders for sale of liquor at military canteen, namely:-
