NOTIFICATION

No. F.12 (1)/2002-03/Fin (E-I)/(iii) – In exercise of the powers conferred by sub-section (1) of section 6 of the Delhi Entertainments and Betting Tax Act, 1996 (Delhi Act 8 of 1997), the Lt. Governor of the National Capital Territory of Delhi, hereby exempts, with immediate effect, holding of magic shows in the National Capital Territory of Delhi from the liability to pay the entertainment tax, subject to the condition that prior intimation about the show shall be given to the Commissioner of Entertainment Tax, Government of Delhi.
This notification is in supersession of the earlier notification No. F.12(20)/95-Fin(G)/423 dated the 25th Sep. 1995, on the subject and in force immediately before this notification.
