NOTIFICATION

No. F.12 (1)/2004-05/Fin (E-1)/(IV) - In exercise of the powers conferred by sub-section (1) of section 8 of the Delhi Entertainments and Betting Tax Act, 1996 (Delhi Act 8 of 1997), the Lt. Governor of the National Capital Territory of Delhi hereby exempts, with immediate effect, all circus performance from the liability to pay the entertainment tax, subject to fulfilling the following conditions, namely :-

- (i) that prior intimation about show is given to the Commissioner of Entertainment Tax, Delhi;
 - (ii) that students, on production of Identity Cards or block reserved by the school for their students, will be given 50% concessions on the face value of entry fee.
- If any person holds a performance, in violation of any of the above conditions, the tax due shall be recoverable in accordance with the provisions of the said Act, and the rules made thereunder

This Government reserves the right to withdraw the exemption, without assigning any reason.

This notification is in supersession of the earlier notification No. F.10(103)/92-Fin(G) dated the 3rd January 1995, on the subject and in force immediately before this notification.
