No.F.10(12)/Fin(T&E) 2008-09— In exercise of the powers conferred by section 58 of the Punjab Excise Act, 1914 (Punjab Act 1 of 1914) as extended to the National Capital Territory of Delhi, the Lieutenant Governor of the National Capital Territory of Delhi is pleased to make the following rules further to amend the Delhi Liquor Licence Rules, 1976 and since it is considered that they should be brought into force at once, he is further pleased to direct that they shall come into force without previous publication, namely:-

<u>Short title and commencement</u>	1.	(1)	These rules may be called the Delhi Liquor Licence (Amendment) Rules, 2009
		(2)	They shall come into force at once
<u>Amendment of rule 24</u>	2.		In the Delhi Liquor Licence Rules 1976 (hereinafter referred to as the "Principal Rules") in Rule 24 :-
		(a)	In clause (c) of clause (ii) for the figures "Rs. 1,00,000/-" the figures " Rs.2,00,000.00" shall be substituted.
		(b)	in sub-clause (g) of clause (ii) for the figures "Rs. 50,000/-" the figures "Rs. 1,00,000.00" shall be substituted.
		(c)	After sub-clause (g) of clause (ii),the following clause shall be added namely :- "(h) L-52 (retail vend of Foreign Liquor in private sector) – Rs. 6,00,000.00 per annum."
<u>Amendment of rule 31A</u>	3.		In the principal Rules, in rule 31A, for the existing sub-rule (l), the following sub-rule shall be substituted namely :-  "(l) The Excise Commissioner shall invite applications for the grant of licence in form L-1 on regular basis and the Applications shall be accepted throughout the licencing year."
