NOTIFICATION

No.F.14(15)/LA-2011/cons law/110 - The following Act of the Legislative Assembly of the National Capital Territory of Delhi received the assent of the President of India on 4th July, 2012 and is hereby published for general information:-

"THE INDIAN STAMP (DELHI AMENDMENT) ACT, 2012
(DELHI ACT 10 OF 2012)

(As passed by the Legislative Assembly of the National Capital Territory of Delhi on the 4th June, 2012)

[4th July, 2012]

further to amend the Indian Stamp Act, 1899 in its application to the National Capital Territory of Delhi.

BE it enacted by the Legislative Assembly of the National Capital Territory of Delhi in the Sixty-thirty Year of the Republic of India as follows:-

1. Short title, extent and commencement.- (1) This Act may be called the Indian Stamp (Delhi Amendment) Act, 2012.

(2) It extends to the whole of the National Capital Territory of Delhi.

(3) It shall come into force on such date as the Lieutenant Governor of the National Capital Territory of Delhi may, by notification in the Delhi Gazette, appoint.

2. Amendment of Schedule I-A.- In the Indian Stamp Act, 1899(2 of 1899) as in force in the National Capital Territory of Delhi, in Schedule I-A, in Article No. 10 for clauses (a) and (b), the following clauses shall be substituted, namely:-

10. ARTICLES OF ASSOCIATION OF A COMPANY

Description of Instrument	Proper Stamp Duty
(a) When the Authorized capital of the Company does not exceed rupees on lakh;	0.15% of the Authorized share capital.
(b) In other cases;	0.15% of the Authorized share capital with a monetary ceiling of rupees twenty five lakhs
(c) When the Authorized share capital is increased	0.15% of the increase in Authorized share capital with a monetary ceiling of rupees twenty five lakhs."

राष्ट्रीय राजधानी क्षेत्र दिल्ली में यथा प्रवृत्त भारतीय मुद्रांक शुल्क अधिनियम, 1899 में और आगे संशोधन करने के लिये अधिनियम ।

भारत गणराज्य के तिरसठवें वर्ष में राष्ट्रीय राजधानी क्षेत्र दिल्ली की विधानसभा द्वारा निम्नलिखित रूप में यह अधिनियमित हो :-

(1) इस अधिनियम को भारतीय मुद्रांक (दिल्ली संशोधन) अधिनियम, 2012 कहा जाए। (2) यह समस्त राष्ट्रीय राजधानी क्षेत्र दिल्ली में विस्तारित होगा। (3) यह राष्ट्रीय राजधानी क्षेत्र दिल्ली के उपराज्यपाल द्वारा दिल्ली राजपत्र में अधिसूचना द्वारा यथा नियत तारीख से प्रभावी होगा।
