**NOTIFICATION**

No.F.10(2)/Fin.(Rev-1)/2012-13.- In exercise of the powers conferred by sub-section (1) of section 81 of the Delhi Excise Act,2009(Delhi Act 10 of 2010), the Government of National Capital Territory of Delhi hereby makes the following rules further to amend the Delhi Excise Rules,2010, namely:-

1. **Short Title and Commencement** .-(1). These rules may be called the Delhi Excise ( Second Amendment) Rules,2012.  
(2) They shall come into force on the date of their publication in the Delhi Gazette
2. **Amendment of rule 152.** - In the Delhi Excise Rules, 2010(herein after referred as 'principal rules'), in rule 152, in sub-rule(1), after the table in clause(iii), the following proviso shall be inserted, namely :-  
" Provided that the rate of duty payable in respect of Beer manufactured by Microbrewery shall be @ Rs.15/- per bulk litre."
3. **Amendment of rule 154.**- In the principal Rules , in rule 154, in sub-rule (2), in the table 'licence fees for other categories of licences', the row at S.No. 13 , shall be substituted, by the following namely:-
