**NOTIFICATION**

No. F.10(1)/Fin(Rev-I)/12-13 :- In exercise of the powers conferred by sub-section (1) of section 81 of the Delhi Excise Act, 2009 (Delhi Act 10 of 2010), the Government of National Capital Territory of Delhi hereby makes the rules further to amend the Delhi Excise Rules, 2010 as following, namely:-

**1. Short Title and Commencement:**

- (1) These rules may be called the Delhi Excise (Fourth Amendment) Rules, 2012.
- (2) They shall come into force on the date of their publication in the Delhi Gazette.

**2. Amendment of rule-2:-** In the Delhi Excise Rules, 2010, in rule 2 for clause (14) the following shall be substituted, namely :-

*"(14) economy Indian liquor' means low cost liquor which includes Delhi Economy Liquor(75 degrees) and Delhi Medium Liquor(60 degrees) as declared by the Excise Commissioner"*

**3. Amendment of rule-32 -** In the Delhi Excise Rules, 2010, in rule 32, in sub-rule (1) for the entries of L-8 and L-14 against serial numbers 13 and 21, the following entries shall be substituted, namely :-

**4. Amendment of rule 55 :-** In the Delhi Excise Rules, 2010, in rule 55, in sub-rule (9) for clause (b), the following clause shall be substituted, namely :-

*“(b) A licensee for the sale of Indian Liquor and Foreign Liquor of the strength less than 25 degrees under proof in the case of brandy, whisky or rum or of a liquor intended to pass as, whisky, brandy or rum or of a strength less than 35 degrees under proof in the case of gin, vodka or of liquor intended to pass as gin or vodka:*

*Provided that the minimum strength of 25 degrees or 35 degrees under proof shall not be enforced in case of liqueur, wine, beer, cider and alcopop:*

*Provided further that the minimum strength of 25 degrees or 35 degrees under proof shall not be enforced in case of Delhi Medium Liquor whose strength will be decided by the Govt. from time to time.”*

**5. Amendment of rule 152:-** In the Delhi Excise Rules, 2010, in rule 152, after sub-rule (4), the following shall be inserted, namely :-

*“(5) The duty to be levied on Delhi Medium Liquor (60 Degrees) shall be 190 per cent of the WSP.”*

**6. Amendment of rule 154 :** In the Delhi Excise Rules, 2010, in rule 154, in sub-rule (2) for the entries against serial number 10 and 16 relating to forms of Licenses L-8 and L-14, the following entries shall be respectively substituted namely :-
