No. F. 10(210)/Ex./IMFL/2011-12/142.—In pursuance of the provision of Rule 52 of Delhi Excise Rules, 2010, it is hereby ordered that "Dry Days" shall be observed from 5.00 PM on 26-2-2012 (Sunday) to 5.00 PM on 28-2-2012 (Tuesday) i.e. Polling Days, on account of Uttar Pradesh Vidhan Sabha Election 2012, by the L-6, L-6FG, L-6FE, L-7, L-7FG, L-7FE, L-8, L-10, L-12, L-12F, L-14 licencees whose retail vends are situated within 500 meter distance from Delhi-U.P. border in the National Capital Territory of Delhi.

The above shall be observed as "Dry Days" for aforementioned licencees whose retail vends are situated within 500 meter distance from Delhi-U.P. border in the NCT of Delhi, in addition to the Dry Days notified *vide* Notification No. F. 10(56)/96-97/IMFL/Ex./3838-3852, dated 1-12-2011 and the compliance for observing the Dry Days shall be strictly adhered to by the all concerned Corporations and individual licencee.
