

Governor of the National Capital Territory of Delhi is pleased to appoint Mr. Shahabuddin, an officer of the Delhi Higher Judicial Service, as Presiding Officer, Labour Court No.IX, Karkardooma, constituted for the National Capital Territory of Delhi, in place of Sh. R.K.Jain, an officer of the Delhi Higher Judicial Service, with effect from the date of assuming charge.

Governor of the National Capital Territory of Delhi is pleased to specify the Labour Court No.IX, presided over by Mr. Shahabuddin, for determining the amount at which any benefit or money that any workman may be entitled to receive from his employer and which is capable of being computed in terms of money, may be computed.


