Sunil Kumar Verma, DANICS (Probationer) (2) Shri Amit Kumar, DANICS (Probationer) and (3) Shri Prashant Kumar, DANICS (Probationer) (4) Shri Shingare Ramchandra Mahadev, DANICS(Probationer) (5) Shri Ramesh Chander Meena, DANICS(Probationer) and (6) Shri Akhil Kumar, DANICS (Probationer)** the power of Assistant Collector, Ist Class under the said Act within the National Capital Territory of Delhi w.e.f. the date of assumption of charge and so long as they hold the post of Sub-Divisional Magistrate in the Revenue Department or till further orders whichever is earlier.
2. **No. 1(743)GA/Estt./DC/R/P./2012** - In exercise of the powers conferred by sub-section (1) of section 15 read with 223 of the Uttar Pradesh Land Revenue Act, 1901(Act No. III of 1901) as extended to the National Capital Territory of Delhi, the Lt. Governor of National Capital Territory of Delhi hereby appoints **(1) Sh. Sunil Kumar Verma, DANICS (Probationer) (2) Shri Amit Kumar, DANICS (Probationer) and (3) Shri Prashant Kumar, DANICS (Probationer) (4) Shri Shingare Ramchandra Mahadev, DANICS(Probationer) (5) Shri Ramesh Chander Meena, DANICS(Probationer) and (6) Shri Akhil Kumar, DANICS (Probationer)** as Assistant Collector, Ist Grade under the said Act within the National Capital Territory of Delhi, and confers upon them all the powers of Collector under the said Act within the National Capital Territory of Delhi w.e.f. the date of assumption of charge and so long as they hold the post of Sub-Divisional Magistrate in the Revenue Department or till further orders whichever is earlier.
3. **No. 1(743)/GA/Estt./DC/R/P./2012** - In exercise of the powers conferred by sub-section (1) within the National Capital Territory of Delhi of section 7 read with 76 of the Delhi Land Revenue Act, 1954 (Act No. 12 of 1954) the Lt. Governor of National Capital Territory of Delhi, hereby appoints **(1) Sh. Sunil Kumar Verma, DANICS (Probationer) (2) Shri Amit Kumar, DANICS (Probationer) and (3) Shri Prashant Kumar, DANICS (Probationer) (4) Shri Shingare Ramchandra Mahadev, DANICS(Probationer) (5) Shri Ramesh Chander Meena, DANICS(Probationer) and (6) Shri Akhil Kumar, DANICS (Probationer)** as Assistant Collector, Ist Class and Revenue Assistant in the National Capital Territory of Delhi and confers upon them all the powers of Collector under the said Act within the National Capital Territory of Delhi w.e.f. the date of assumption of charge and so long as they hold the post of Sub-Divisional Magistrate in the Revenue Department or till further orders whichever is earlier.
4. **No. 1(743)/GA/Estt./DC/R/P./2012** - In exercise of the powers conferred by section 4 read with clause 6 of section 3 of the Northern India Canal & Drainage Act, 1873(Act No. 2 of 1873) as enforced in the National Capital Territory of Delhi, the Lt. Governor of National Capital Territory of Delhi hereby appoints **(1) Sh. Sunil Kumar Verma, DANICS (Probationer) (2) Shri Amit Kumar, DANICS (Probationer) and (3) Shri Prashant Kumar, DANICS (Probationer) (4) Shri Shingare Ramchandra Mahadev, DANICS(Probationer) (5) Shri Ramesh Chander Meena, DANICS(Probationer) and (6) Shri Akhil Kumar, DANICS (Probationer)** as Collector, to exercise or perform the duties conferred or imposed under the said Act within the National Capital Territory of Delhi w.e.f. the date of assumption of charge and so long as they hold the post of Sub-Divisional Magistrate in the Revenue Department or till further orders whichever is earlier.

Governor of National Capital Territory of Delhi is pleased to appoint **(1) Sh. 


