- 1. Short Title and Commencement.- (1) These rules may be called the Delhi Excise (Amendment) Rules, 2013.
 - (2) They shall come into force on the date of their publication in the Official Gazette
- 2. Amendment of rule 32 .- In rule 32 of the Delhi Excise Rules, 2010, for entries in the column 'Details of Licenses' against Sr.No.22, 23,24 and 25, the following shall be substituted, namely:
