**NOTIFICATION**

In exercise of the powers conferred by section 51 of the Delhi Tax on Luxuries Act, 1996, (Delhi Act 10 of 1996) and all other powers enabling him in that behalf, the Lieutenant Governor of the National Capital Territory of Delhi, hereby makes the rules to amend the Delhi Tax on Luxuries Rules, 1996, as following, namely:-

1. **Short title and commencement.** – (1) These rules may be called the Delhi Tax on Luxuries (Amendment) Rules, 2013.

(2) These rules shall come into force on the date of their publication in the official Gazette.

2. **Substitution of the words "Luxury Tax Officer".** – In the Delhi Tax on Luxuries Rules, 1996 (hereinafter referred as the principle Rules) and Forms appended thereto, for the words "Luxury Tax Officer", wherever they occur, except in rules 4 and 45, the words "Assistant Commissioner of Luxury Tax" shall be substituted.

3. **Amendment of Forms.** – In the principle Rules, in the forms appended thereto, –

(a) in Form 1, after the number and words "4. Registration No." and before the table, the following shall be inserted, namely:-

"5. Date from which tariff is revised:"

(b) in Form 1A, after the number and words "4. Registration No." and before the table, the following shall be inserted, namely:-

"5. Date from which tariff is revised:"

- (c) in Form 8; at item No. 2.C of Part-I, for the words and numbers "rule 3(1)(i) and (ii)", appearing after the words "refer to", the words and numbers "rule 3(2)(b)(ii)" shall be substituted.
- (d) in Form 15, at item No. 2.C of Part-I, for the words and numbers "rule 3(1)(i) and (ii)", appearing after the words "refer to", the words and numbers "rule 3(2)(b)(ii)" shall be substituted.
