No.F.12(2)/Fin.(Rev.-I)/2013-14-In exercise of the powers conferred by sub-section (2) of section 7 of the Delhi Tax on Luxuries Act, 1996 (Delhi Act 10 of 1996) (hereinafter referred to as the 'said Act') and in supersession of this Government's earlier Notifications No. F.10(105)/95-Fin.(G) dated 28.01.1997 & F.10(43)/2001-02/Fin.-(E-I)/126KHA dated 08.05.2002, the Lieutenant Governor of National Capital Territory of Delhi, hereby notifies that each of the officers mentioned in column 2 of the schedule mentioned below, shall exercise such powers and perform such functions as may be required under the sections of the said Act, respectively specified against them in column 3 of the said schedule:
