**NOTIFICATION**

No.F.10(7)/Fin(Rev-I)/2013-14/ : Whereas the exemption from payment of luxury tax in respect of High Commission of the Republic of Singapore and their employees was withdrawn vide notification No.F.12(1)/Fin.(T&E)/2008-09/jsfin./280 dated 23.06.2008.

2. And whereas, the Government of National Territory of Delhi is of the opinion that it is expedient in public interest so to do.

3. Now, therefore, in exercise of the powers conferred by sub-section (1) of section 22 of the Delhi Tax on Luxuries Act, 1996 (Delhi Act No. 10 of 1996), the Government of National Capital Territory of Delhi, hereby restores the exemptions allowed vide notification No.F.10(3)97-Fin.(G)/64-73 dated 15.05.2000 in case of High Commission of the Republic of Singapore, New Delhi and their employees for official use only and not for their personal use by withdrawing the notification No.F. 12(1)/Fin.(T&E)/2008-09/jsfin./280 dated 23.06.2008 from the date of issue i.e. 23.06.2008, till the Ministry of External Affairs, Government of India decides otherwise.

4. This notification shall come into force from the date of its publication in the official gazette.
