NOTIFICATION

No.F.10(5)/Fin(Rev-I)/2013-14/ .- In exercise of the powers conferred by sub-section (1) of section 81 of the Delhi Excise Act, 2009 (Delhi Act 10 of 2010), the Government of National Capital Territory of Delhi hereby makes the following rules to further amend the Delhi Excise Rules, 2010, namely:-

1. **Short title and commencement:** (1) These rules may be called the Delhi Excise (Amendment) Rules, 2013.
(2) They shall come into force on the date of their publication in the official Gazette.
2. **Amendment of rule 32.-** In the Delhi Excise Rules, 2010 in rule 32, in sub rule (1) “Class of licences and authorities to grant and renew licences”, after Sl.No.14, the following shall be inserted, namely:-
