

RECOMMENDATIONS OF THE SENTENCE REVIEWING BOARD IN THE MEETING HELD UNDER THE CHAIRPERSONSHIP OF THE HON'BLE CHIEF MINISTER OF DELHI AT 04:00 PM ON 01st OF OCTOBER, 2013, AT DELHI SECRETARIAT, NEW DELHI- 110002

A meeting of the **Sentence Reviewing Board** (hereinafter referred to as **Board**) was held on **01st of OCTOBER 2013** at the Delhi Secretariat under the **CHAIRPERSONSHIP OF HON'BLE CHIEF MINISTER, NCT OF DELHI.**

On **01st of OCTOBER 2013 at 4:00 P.M.**, the cases of **FIFTY NINE (59) Life Convicts including 04 cases of terminally ill patients in terms of para 3.4 of SRB Guidelines** were taken up by the **Sentence Reviewing Board** for recommending premature release on merits. Such premature releases are subject to the approval of His Excellency, the Lieutenant Governor, Govt. of National Capital Territory of Delhi. Guidelines issued by the Government of NCT of Delhi vide Order No.F.18/5/94/HOME (G)/3825 dated 16.07.2004 and other related records were taken into consideration. Cases were discussed in the light of parameters like conduct of the prisoner during confinement in jail and parole/furlough, his/her age, the circumstances under which the crime was committed, gravity of crime, his/her antecedents, prospects of rehabilitation, family responsibilities etc. Recommendations of Jail Superintendent, Probation Officer and Police Authorities were also taken into account while reviewing each case for premature release.

The fact was placed before the Board that conduct of life convict during last one year only was to be taken into account while considering premature release of convict in consonance of directions passed by the Hon'ble Supreme Court of India.

The cases were taken up by the Board and decided taking into consideration the facts of each case in true spirit of guidelines and conduct of convicts during their incarceration, as under:-

(CASES OF TERMINALLY ILL PATIENTS)

1. PARMANAND S/O SH. JOGESHWAR AGE – 69 Yrs.

The convict is undergoing life imprisonment in case FIR No.186/2008, U/S-302/34 IPC , Police Station- Rohini, Delhi, for commission of murder of his daughter – in- law to get rid of her so as to marry his son with somebody else. The convict is a native of Delhi.

The convict has already undergone an actual sentence of 02 years, 09 months & 28 days excluding the remission as on 30th June 2013. He has undergone a total period of 03 years, 02 months & 17 days including the remission earned by him.

The Delhi Police report opposed premature release of the convict. The residential police not received despite multiple messages. The Chief Probation Officer (Delhi) recommended premature release of the convict.

After taking into account overall facts of the case, nature of crime and very short period undergone by the convict, the Board **REJECTED** the premature release of the convict.

2. SHAHID AHMED S/O SHAFIQ AHMED AGE – 38 Yrs.

The convict is undergoing life imprisonment in case FIR No.474/2005, U/S-302/34 IPC , Police Station- Vikas Puri, Delhi, for involvement in murder of a person due to grudge against him. The convict is a native of Delhi.

The convict has already undergone an actual sentence of 07 years, 10 months & 08 days excluding the remission as on 10th September 2013. He has undergone a total period of 08 years, 07 months & 03 days including the remission earned by him.

The Delhi Police report has not been received despite several letters/messages. The Chief Probation Officer (Delhi) has recommended premature release of the convict.

After taking into account overall facts of the case, nature of crime and very short period undergone by the convict, the Board **REJECTED** the premature release of the convict.

3. BALBIR SINGH S/O SH. BABU LAL AGE – 48 Yrs.

The convict is undergoing life imprisonment in case FIR No.186/2008, U/S-302/34 IPC , Police Station- Rohini, Delhi, for commission of murder of his daughter – in- law to get rid of her so as to marry his son with somebody else. The convict is a native of Delhi.

The convict has already undergone an actual sentence of 06 years, 06 months & 27 days excluding the remission as on 10th September 2013. He has undergone a total period of 08 years, 04 months & 00 days including the remission earned by him.

The residential police not received despite multiple messages. The Chief Probation Officer (Delhi) has not opposed premature release of the convict.

After taking into account overall facts of the case, nature of crime and very short period undergone by the convict, the Board **REJECTED** the premature release of the convict.

4. SUDAMA W/O BUTI THAKUR AGE - 60 Years , was also

placed before the Board for consideration of her premature release in terms of para no. 3.4 of SRB Guidelines 2004 which states –“*Cases of premature release of persons undergoing life imprisonment before completion of 14 years of actual*

imprisonment on grounds of terminal illness or old age etc. Can be dealt with under the provisions of Art. 161 of the Constitution of India. The convict is serving life sentence in case FIR No.478/2003, U/s- 302/201/34 IPC, P.S.- Paschim Vihar, Delhi. The convict has undergone custody period of 09 years 09 months and 21 days without remission and total custody of 11 years, 03 months and 04 days with remission.

After taking into account overall facts of the case, nature of crime and very short period undergone by the convict, the Board **REJECTED** the premature release of the convict.

(ORDINARY 55 CASES)

1. AKIL @ JAVED S/O FAZRUL @ FAZLUR @ ABDUL REHMAN

AGE – 41 Yrs.

The convict is undergoing life imprisonment in case FIR No.777/1998, U/S- 302/354/302/411/34 IPC , Police Station- Sultan Puri, Delhi, for commission of murder of a person and outraging modesty of a lady while committing robbery. The convict is a native of Uttar Pradesh.

The convict has already undergone an actual sentence of 14 years, 07 months & 26 days excluding the remission as on 30th June 2013. He has undergone a total period of 17 years, 11 months & 00 day including the remission earned by him.

The reports from Delhi local police and Home Town police not received despite multiple messages. The Chief Probation Officer (Delhi) has not opposed premature release of the convict. The report from Home Town Probation officer not received despite multiple messages.

After taking into account overall facts of the case, in the absence of reports from the authorities, the Board **DEFERRED** the premature release of the convict.

2. MOHD. AHMED S/O NAWAB AHMED AGE – 44 Yrs.

The convict is undergoing life imprisonment in case FIR No.02/1991, U/S-302/201 IPC , Police Station- Seema Puri, Delhi, for commission of murder of a person at the instance of his accomplice to avert repaying amount as borrowed by his accomplice. The convict is a native of Uttar Pradesh.

The convict has already undergone an actual sentence of 14 years, 07 months & 10 days excluding the remission as on 30th June 2013. He has undergone a total period of 17 years, 01 months & 07 days including the remission earned by him.

The Delhi Police report opposed premature release of the convict. The residential police and Home town Probation Officer reports not received despite multiple messages. The Chief Probation Officer (Delhi) recommended premature release of the convict.

After taking into account overall facts of the case, the Board **RECOMMENDED** the premature release of the convict.

3. BHANU SHAH S/O SH. RAMESH SHAH AGE – 36 Yrs.

The convict is undergoing life imprisonment in case FIR No.99/1999, U/S-302/392/397/34 IPC , Police Station- Welcome, Delhi, for commission of murder of a factory employee while committing robbery in factory. The convict is a foreign national of Nepal.

The convict has already undergone an actual sentence of 14 years, 01 month & 00 days excluding the remission as on 30th June 2013. He has undergone a total period of 17 years, 08 months & 00 day including the remission earned by him.

The Delhi Police and Home Town Police reports not received despite multiple messages. The Chief Probation Officer (Delhi) recommended premature release of the convict. The Home Town Probation Officer report not received despite multiple messages.

After taking into account overall facts of the case, recommendation of the probation officer, the Board **RECOMMENDED** the premature release of the convict

subject to official deportation to the Nepal after furnishing all formalities pertaining to the present case.

4. KARAN BAHADUR S/O SH. SHANKAR BAHADUR AGE – 34 Yrs.

The convict is undergoing life imprisonment in case FIR No.99/1999, U/S-302/392/397/34 IPC , Police Station- Welcome, Delhi, for commission of murder of a factory employee while committing robbery in factory. The convict is a foreign national of Nepal.

The convict has already undergone an actual sentence of 14 years, 01 month & 00 days excluding the remission as on 30th June 2013. He has undergone a total period of 17 years, 08 months & 00 day including the remission earned by him.

The Delhi Police and Home Town Police reports not received despite multiple messages. The Chief Probation Officer (Delhi) recommended premature release of the convict. The Home Town Probation Officer report not received despite multiple messages.

After taking into account overall facts of the case, the Board **RECOMMENDED** the premature release of the convict subject to official deportation to the Nepal after furnishing all formalities pertaining to the present case.

5. BRINDABAN S/O SH. KHAZAN SINGH AGE – 49 Yrs.

The convict is undergoing life imprisonment in case FIR No.262/1999, U/S-302 IPC , Police Station- Najafgarh, Delhi, for commission of murder of his wife during quarrel. The convict is a native of Delhi.

The convict has already undergone an actual sentence of 14 years, 01 month & 16 days excluding the remission as on 30th June 2013. He has undergone a total period of 18 years, 02 months & 20 days including the remission earned by him.

The Delhi Police report has not been received despite multiple messages. The Chief Probation Officer (Delhi) recommended premature release of the convict.

After taking into account overall facts of the case, the Board **DEFERRED** the premature release of the convict with view to watch and observe the conduct of the convict in Semi Open Jail for some more time /one year.

6. BHARAT S/O SH. YAD RAM AGE – 35 Yrs.

The convict is undergoing life imprisonment in case FIR No.380/1998, U/S-364/302/201/34 IPC , Police Station- Najafgarh, Delhi, for commission of kidnapping and murder of his employer for ransom. The convict is a native of Haryana.

The convict has already undergone an actual sentence of 14 years, 00 month & 25 days excluding the remission as on 31st August 2013. He has undergone a total period of 17 years, 10 months & 05 days including the remission earned by him.

The Delhi Police and Home Town Police have not opposed premature release of the convict. The Chief Probation Officer Delhi and Home Town have recommended the premature release of the convict.

After taking into account overall facts of the case, gravity of crime, the Board **DEFERRED** the premature release of the convict.

7. BACHCHI SINGH S/O SH. DHAN SINGH AGE – 58 Yrs.

The convict is undergoing life imprisonment in case FIR No.25/1987, U/S-302/392/34 IPC , Police Station- Lodhi Colony, Delhi, for commission of murder of his ex-employer and his wife while committing robbery. The convict is a native of Uttarakhand.

The convict has already undergone an actual sentence of 14 years, 00 month & 17 days excluding the remission as on 31st August 2013. He has undergone a total period of 15 years, 00 month & 07 days including the remission earned by him.

The Police report (Local & Home Town) and report from Home Town Probation Officer have not been received despite multiple messages. The Chief Probation officer (Delhi) has recommended.

After taking into account overall facts of the case, heinous nature of crime , absence of reports from authorities, the Board **REJECTED** the premature release of the convict.

8. GOPAL S/O SH. DHAN SINGH AGE – 58 Yrs.

The convict is undergoing life imprisonment in case FIR No.25/1987, U/S-302/392/34 IPC , Police Station- Lodhi Colony, Delhi, for commission of murder of his ex-employer and his wife while committing robbery. The convict is a native of Uttarakhand.

The convict has already undergone an actual sentence of 14 years, 00 month & 03 days excluding the remission as on 31st August 2013. He has undergone a total period of 14 years, 11 months & 23 days including the remission earned by him.

The Police report (Local & Home Town) and report from Home Town Probation Officer have not been received despite multiple messages. The Chief Probation officer (Delhi) has recommended.

After taking into account overall facts of the case, heinous nature of crime , absence of reports from authorities, the Board **REJECTED** the premature release of the convict.

9. DILSHAD S/O SALIMUDDIN AGE – 39 Yrs.

The convict is undergoing life imprisonment in case FIR No.91/1993, U/S-394/397/302 IPC , Police Station- Vikas Puri, Delhi, for involvement in murder of a person while committing robbery in his house. The convict is a native of Uttar Pradesh.

The convict has already undergone an actual sentence of 15 years, 05 months & 25 days excluding the remission as on 31st August 2013. He has undergone a total period of 19 years, 09 months & 07 days including the remission earned by him.

The Delhi Police report has opposed premature release of the convict. The Hometown police has not opposed premature release of the convict. The Chief Probation Officer has recommended premature release of the convict. The Hometown probation officer has not opposed premature of the convict.

After taking into account overall facts of the case, positive reports from the Probation Officer and the fact that two co-accused have already been released, the Board **RECOMMENDED** the premature release of the convict.

10 .GAURI SHANKAR S/O SH. JAGESHWAR AGE – 41 Yrs.

The convict is undergoing life imprisonment in case FIR No.94/1991, U/S-452/307/302/392/34 IPC , Police Station- Naraina, Delhi, for involvement in the murder of a person while committing robbery. The convict is a native of Bihar.

The convict has already undergone an actual sentence of 14 years, 02 months & 08 days excluding the remission as on 31st August 2013. He has undergone a total period of 16 years, 06 months & 00 day including the remission earned by him.

The Police report (Local & Home Town) and report from Home Town Probation Officer have not been received despite multiple messages. The Chief Probation officer (Delhi) has recommended.

After taking into account overall facts of the case, recommendation of the Probation Officer, good jail conduct, the Board **RECOMMENDED** the premature release of the convict.

11 GURDEV S/O SH. ASHARFI MANDAL AGE - 43 Yrs.

The convict is undergoing life imprisonment in case FIR No.652/2001, U/S-376/506 IPC , Police Station- Mangol Puri, Delhi, for committing rape upon his own daughter several times in a period of 02 months. The convict is a native of Bihar.

The convict has already undergone an actual sentence of 11 years, 10 months & 19 days excluding the remission as on 30th of June 2013. He has undergone a total period of 14 years, 09 months & 04 days including the remission earned by him.

The Delhi Police opposed premature release of the convict. The Home State Police has not opposed premature release of the convict. The Chief Probation Officer (Delhi) recommended premature release of the convict. The Home State Probation Officer report has not been received despite multiple messages.

After taking into account overall facts of the case, negative report of the police authorities, nature of crime, the Board **REJECTED** the premature release of the convict.

12 HEM CHAND S/O SH. RAJA RAM**AGE – 36 Yrs.**

The convict is undergoing life imprisonment in case FIR No.188/1999, U/S-302/34 IPC & r/w 120-B IPC, Police Station- Mehrauli, Delhi, for his involvement with accomplices in murder of a lady at the instance of kingpin Romesh Sharma. The convict is a local resident of Delhi.

The convict has already undergone an actual sentence of 14 years, 01 month & 17 days excluding the remission as on 30th of June 2013. He has undergone a total period of 15 years, 11 months & 24 days including the remission earned by him.

The local police has not opposed premature release of the convict. The residential police opposed the premature release of the convict. The Chief Probation Officer (Delhi) has not opposed premature release of the convict. The convict was involved in other crimes.

After taking into account overall facts of the case, the Board **DEFERRED** the premature release of the convict.

13 .RAMESH S/O SH. MUNNA LAL,**AGE – 36 Yrs.**

The convict is undergoing life imprisonment in case FIR No.188/1999, U/S-302/120-B/34 IPC, Police Station- Mehrauli, Delhi, for his involvement with accomplices in murder of a lady at the instance of kingpin Romesh Sharma. The convict is a local resident of Delhi.

The convict has already undergone an actual sentence of 14 years, 01 month & 17 days excluding the remission as on 30th of June 2013. He has undergone a total period of 15 years, 09 months & 09 days including the remission earned by him.

The Delhi Police opposed premature release of the convict. The Chief Probation Officer (Delhi) recommended premature release of the convict.

After taking into account overall facts of the case, the Board **DEFERRED** the premature release of the convict.

14 SANT RAM S/O SH. RAM GANESH AGE – 36 Yrs.

The convict is undergoing life imprisonment in case FIR No.188/1999, U/S-302/34 IPC & r/w 120-B IPC, Police Station- Mehrauli, Delhi, for his involvement with accomplices in murder of a lady at the instance of kingpin Romesh Sharma. The convict is a local resident of Delhi.

The convict has already undergone an actual sentence of 14 years, 01 month & 27 days excluding the remission as on 30th of June 2013. He has undergone a total period of 15 years, 10 months & 08 days including the remission earned by him.

The Police opposed premature release of the convict. The Chief Probation Officer (Delhi) has not recommended premature release of the convict. The convict was involved in other crimes.

After taking into account overall facts of the case, the Board **DEFERRED** the premature release of the convict.

15 SURENDER MISHRA S/O SH. BHAGWAN DASS AGE – 38 Yrs.

The convict is undergoing life imprisonment in case FIR No.188/1999, U/S-302/34 IPC & r/w 120-B IPC, Police Station- Mehrauli, Delhi, for his involvement with accomplices in murder of a lady at the instance of kingpin Romesh Sharma. The convict is a native of Uttar Pradesh.

The convict has already undergone an actual sentence of 14 years, 02 months & 26 days excluding the remission as on 30th of June 2013. He has undergone a total period of 15 years, 11 months & 17 days including the remission earned by him.

The Delhi Police did not oppose premature release of the convict. The residential police report has not been received despite multiple messages.

The Chief Probation Officer Delhi & Home State recommended premature release of the convict. The convict was involved in other crimes.

After taking into account overall facts of the case, the Board **DEFERRED** the premature release of the convict with view to watch and observe the conduct of the convict in Semi Open Jail for some more time /one year.

16 MOHD. HUSSAIN ANSARI S/O MUNSHI MIYAN AGE – 40 Yrs.

The convict is undergoing life imprisonment in case FIR No.130/1999, U/S-30 IPC & Section 04 of Dowry Prohibition Act, Police Station- Narayana, Delhi, for murder of his wife for insufficient dowry. The convict is a native of Uttar Pradesh.

The convict has already undergone an actual sentence of 14 years, 00 month & 12 days excluding the remission as on 30th June 2013. He has undergone a total period of 17 years, 03 months & 13 days including the remission earned by him.

The Delhi Police opposed premature release of the convict. The residential police has not opposed premature release of the convict. The Chief Probation Officer (Delhi) recommended premature release of the convict. The Home State Probation Officer report has not been received despite multiple messages.

After taking into account overall facts of the case, nature of crime, the Board **REJECTED** the premature release of the convict.

17 JALBIR S/O SH. SURESH CHAND AGE - 37 Yrs.

The convict is undergoing life imprisonment in case FIR No.177/1997, U/s-394/302/34 IPC, Police Station- Sri Niwas Puri, Delhi for committing murder of maid servant who had intervened when they were committing dacoity in the house of his relative. The convict is a native of Uttar Pradesh.

The convict has already undergone an actual sentence of 14 years, 00 month & 09 days excluding the remission as on 30th of June 2013. He has undergone a total period of 15 years, 10 months & 11 days including the remission earned by him.

The Police opposed premature release of the convict. The Chief Probation Officer (Delhi) recommended premature release of the convict. The Home State Probation Officer report has not been received despite multiple messages.

After taking into account overall facts of the case, nature of crime, the Board **DEFERRED** the premature release of the convict.

18 JEET SINGH S/O SH. JOGENDER SINGH AGE – 43 Yrs.

The convict is undergoing life imprisonment in case FIR No.13/1999, U/S-302/380/411 IPC, Police Station- Saraswati Vihar, Delhi, for murder of a lady and stealing away ornaments. The convict is a local resident of Delhi.

The convict has already undergone an actual sentence of 14 years, 02 months & 20 days excluding the remission as on 30th of June 2013. He has undergone a total period of 18 years, 00 month & 00 day including the remission earned by him.

The Delhi Police opposed premature release of the convict. The residential police could not find the address, hence no report. The Delhi Chief Probation Officer recommended premature release of the convict.

After taking into account overall facts of the case, nature of crime, the Board **DEFERRED** the premature release of the convict.

19 KUNDAN S/O SH. SHIV NARAYAN AGE – 41 Yrs.

The convict is undergoing life imprisonment in case FIR No.284/1996, U/S-302/323/397/34 IPC , Police Station- Model Town, Delhi, for commission of murder of his ex-employer's wife while committing dacoity in her house. The convict is a native of Bihar.

The convict has already undergone an actual sentence of 16 years, 02 months & 21 days excluding the remission as on 30th June 2013. He has undergone a total period of 17 years, 11 months & 16 days including the remission earned by him.

The Delhi Police report has not been received despite multiple letters/messages. The residential police not opposed premature release of the convict. The Chief Probation Officer (Delhi) recommended premature release of the convict. The Home Town Probation Officer report has not been received despite multiple letters/messages.

After taking into account overall facts of the case, positive report of probation officer, the Board **RECOMMENDED** the premature release of the convict.

20 KALICHARAN S/O SH. GURDAYAL AGE – 36 Yrs.

The convict is undergoing life imprisonment in case FIR No.485/1998, U/S-302/324/397/506 (II) IPC, Police Station- Trilok Puri, Delhi, for commission of murder of a person while committing robbery and extending threat to a lady of dire consequences. The convict is a native of Uttar Pradesh.

The convict has already undergone an actual sentence of 14 years, 09 months & 17 days excluding the remission as on 30th June 2013. He has undergone a total period of 19 years, 00 months & 21 days including the remission earned by him.

The Delhi Police and Home Town police report have opposed premature release of the convict. The Chief Probation Officer (Delhi) recommended premature release of the convict. The Home Town Probation Officer report has not been received despite multiple letter/messages.

After taking into account overall facts of the case, positive report of probation officer, the Board **RECOMMENDED** the premature release of the convict.

21 PRAMOD KUMAR S/O SH. PREM SINGH AGE – 39 Yrs.

The convict is undergoing life imprisonment in case FIR No.138/1999, U/S-302/332/186 IPC & 27 Arms Act, Police Station- Vasant Kunj, Delhi, for commission of murder of a police constable when the accused was surrounded by the raiding police team. The convict is a local resident of Delhi.

The convict has already undergone an actual sentence of 14 years, 03 months & 09 days excluding the remission as on 30th June 2013. He has undergone a total period of 17 years, 08 months & 08 days including the remission earned by him.

The Police report has not been received despite multiple messages. The Chief Probation Officer (Delhi) recommended premature release of the convict.

After taking into account overall facts of the case, nature of crime, the Board **REJECTED** the premature release of the convict.

22 RAMESH @ BAJRANGI S/O SH. DEEPA RAM AGE – 42 Yrs.

The convict is undergoing life imprisonment in case FIR No.379/1999, U/S-363/376/302 IPC, Police Station- Saraswati Vihar, Delhi, for committing rape and murder of a female child residing in his neighbourhood. The convict is a local resident of Delhi.

The convict has already undergone an actual sentence of 14 years, 02 months & 24 days excluding the remission as on 31st of August 2013. He has undergone a total period of 16 years, 11 months & 04 days including the remission earned by him.

The Delhi Police opposed premature release of the convict. The Chief Probation Officer (Delhi) has not recommended premature release of the convict.

After taking into account overall facts of the case, nature of crime, negative report of the police, the Board **REJECTED** the premature release of the convict.

23 SUNIL S/O SH. KEDAR SINGH AGE – 41 Yrs.

The convict is undergoing life imprisonment in case FIR No.163/1999, U/S-302 IPC, Police Station- New Ashok Nagar, Delhi, for committing murder of his wife due to insufficient dowry. The convict is a local resident of Delhi.

The convict has already undergone an actual sentence of 14 years, 00 month & 14 days excluding the remission as on 31st of August 2013. He has undergone a total period of 17 years, 03 months & 14 days including the remission earned by him.

The Delhi Police has not been received despite multiple letters / messages. The Chief Probation Officer (Delhi) recommended premature release of the convict.

After taking into account overall facts of the case, the Board **DEFERRED** the premature release of the convict with view to watch and observe the conduct of the convict in Semi Open Jail for some more time /one year.

After taking into account overall facts of the case, heinous nature of crime, jail conduct being not satisfactory, report from concerned authorities, the Board **REJECTED** the premature release of the convict.

53 VIJAY S/O SH. RATTAN LAL**AGE - 35 YEARS**

The convict is undergoing life imprisonment in case FIR No. 376/1996, U/S-302/394/34 IPC & 25/54/59 Arms Act, Police Station- Mangol Puri, Delhi, for involvement in loot and murder of a petrol pump employee. The convict is a native of Haryana.

The convict has already undergone an actual sentence of 15 years, 09 months & 09 days excluding the remission as on 30th of June 2013. He has undergone a total period of 15 years, 10 months & 21 days including the remission earned by him.

The Police has opposed premature release of the convict. The Home State police has not opposed premature release of the convict. The Social Investigation Report from the Chief Probation Officer, Bhiwani, Haryana have not been received despite several letters/wireless messages.

After taking into account overall facts of the case, heinous nature of crime as loot and murder of a petrol pump employee, unsatisfactory jail conduct, his involvement in number of heinous crimes, the Board **REJECTED** the premature release of the convict.

54 VIJAY S/O SH. HARKESH**AGE - 37 Yrs.**

The convict is undergoing life imprisonment in case FIR No. 697/1995, U/S-302 IPC, Police Station- Patel Nagar, Delhi, for intruding into jhuggi and causing assault on the neck of a girl of 13 years namely Gunjan with a barbar's razor when she rebuffed his amorous advances. The convict is a native of District- Sultan Pur, Uttar Pradesh.

The convict has already undergone an actual sentence of 17 years, 09 months & 23 days excluding the remission as on 30th of June 2013. He has undergone a total period of 23 years, 02 months & 06 days including the remission earned by him.

The Local Police has opposed premature release of the convict. The Residential Police has opposed premature release of the convict. The Local Chief Probation Officer has recommended premature release of the convict. Social Investigation Report from his residential area has not been received in spite of several letters and wireless messages.

After taking into account overall facts of the case, the Board **DEFERRED** the premature release of the convict with view to watch and observe the conduct of the convict in Semi Open Jail for some more time /one year.

In the meeting, the Board was apprised of problems being faced by the life convicts whose cases are approved for premature release by the Hon'ble Lieutenant Governor of Delhi but their proposed surety in furnishing surety formalities in the office of the SDMs taking unusually long time for acceptance with the result the convict has to remain in avoidable unauthorized confinement. The relatives of the convicts are generally illiterate & poor thus can not run to the far flung located offices of SDMs to get surety accepted. During last two SRB meetings held on 07.01.13 & on 24.06.13 total cases approved by Hon'ble L.G. for premature release were 17, but out of which only 10 have been released so far & others are still pending for acceptance of surety

It was also brought to notice of the Board that before the introduction and implementation of Parole/Furlough Guidelines 2010, the life convicts were ordered to furnish surety in the office of the SDMs, and in view of the prolong process of furnishing surety in SDM offices by the sureties, practice/procedure was changed, it was ordered to furnish surety in the office of the Superintendent of the concerned jail and the said practice is prevalent at present which takes minimum time & without giving any hassles and inconvenience to the relatives/sureties of the convicts.

After discussion at length, the Board agreed that the Superintendent of concerned Jail may be empowered to accept sureties / personal bond in premature release cases as he is already accepting sureties in cases of Parole / Furlough also. Accordingly, it was decided by the Board that a separate proposals may be sent in this regard for obtaining kind approval of Hon'ble L.G.

Conclusion: Out of 59 cases placed before the Sentence Reviewing Board, 13 cases have been recommended, 17 cases have been deferred and 29 cases have been rejected.
