NOTIFICATION

Whereas the Lt. Governor of the National Capital Territory of Delhi is of the opinion that it is expedient in the interest of general public so to do;

Now, therefore, in exercise of the powers conferred by section 103 of the Delhi Value Added Tax Act, 2004 (Delhi Act 3 of 2005), the Lt. Governor of the National Capital Territory of Delhi, hereby, makes the following amendments in the Schedules appended to the said Act, namely :-

AMENDMENTS

1. In the Third Schedule, in Entry at serial No. 86, in sub-entry (xxviii), after the words and symbol "Spare parts, accessories and components" and before the words "of the plant and machinery", the words, symbol and brackets "(other than electric motors, switchgears and starters)" shall be inserted
2. In the Fourth Schedule, in the Table,-
 - (a) for the row pertaining to Entry at serial No. 1, the following row shall be substituted, namely:-

1.	Petroleum Products [other than Petrol (Motor Spirit), Diesel, Aviation Turbine Fuel, Liquid Petroleum Gas, Piped Natural Gas, Compressed Natural Gas, Wax and Kerosene] such as (i) Naptha; (ii) Lubricants; (iii) Furnace oil; (iv) Mixture and combination of above products.	Twenty paise in the rupee

"; and

- (b) after the row pertaining to entry at Serial.No.13, the following row shall be inserted, namely:-

14.	Aviation Turbine Fuel (ATF)	25 paise in the rupee
