**NOTIFICATION**

No.F.6/3/2014-Judl./Suptlaw/1277-1282 : - In pursuance of the provisions of rule 18 of the Delhi Judicial Service Rules, 1970 as amended up to date, the Lt. Governor of the National Capital Territory of Delhi, in consultation with the High Court of Delhi, is pleased to appoint Ms. Prigya Verma as member of the Delhi Judicial Service on probation for a period of two years with effect from the date she assumes charge of her office on being posted by the Delhi High Court, New Delhi.

2. This appointment is on purely provisional basis, and subject to the verification of the caste/PH category certificate, where ever applicable. If the verification reveals that the claim to belonging to Scheduled Caste and Scheduled Tribe or Physically Handicapped category, as the case may be, is false, the services will be terminated forthwith without assigning any further reasons and without prejudice to such further action as may be taken under the provisions of the Indian Penal Code for production of false certificate.

3. The above appointment shall be subject to the provisions of the Delhi Judicial Service Rules, 1970 as amended up to date and other orders/instructions as may be applicable to the officers of the Delhi Judicial Service from time to time.

4. The inter-se seniority of the above named candidate in the Delhi Judicial Service vis-à-vis other selected candidates will remain the same as assigned to her in the merit list prepared by the Selection Committee in accordance with the provisions of the Delhi Judicial Service Rules, 1970 as amended up to date.

5. The above appointment shall be subject to outcome of WP(C) No.514/2015 titled 'Centre for Public Interest Litigation Vs. Registrar General of the High Court of Delhi' pending before the Hon'ble Supreme Court of India and WP (C) No.2828/2010 titled 'Surender Pal Singh Chauhan Vs. State & Anr.' Pending before the Hon'ble High Court of Delhi.

6. The post carries the scale of pay of Rs.27700-770-33090-920-40450-1080-44770 plus usual allowances as may be applicable in this behalf from time to time.
