Short Title and 1 Commencement

- (1) These rules may be called the Delhi Motor Vehicles (Amendment) Rules, 2018.
- (2) They shall come into force on the date of their publication in the Delhi Gazette.

Amendment in Rule 34 A (1)

In the Delhi Motor Vehicles Rules, 1993, in Rule 34A, for sub-rule(1), the following shall be substituted,

"In case of non-transport four wheeled vehicle and two wheeled vehicle, the assignment of registration mark as specified in column 1 of the table given below, in any available series of registration marks shall be made available only on payment of additional fee to the highest bidder selected through open auction in respect of category 1, 2, 3 & 4 and on payment of additional fee in respect of category 5 & 6 as per table given below:-
