**F. No. 20/4/2003/HP-II/6128.**—Whereas, the plying of vehicles in both the directions on the road with entry from Munirka Marg (Priya Complex Road) adjacent Hotel Vasant Continental to Vasant Lok Hospital Road and on the road behind Vasant Complex connecting Poorvi Marg with Vasant Lok Hospital Road is creating congestion and problem in smooth flow of traffic on this road.

And whereas, it is necessary to ensure the smooth flow of traffic, to prevent congestion and inconvenience to motorists, other road users and for the safety of general public on this road.

Now, therefore, I, Mukesh Kumar Meena, Deputy Commissioner of Police, Traffic (HQ.) Delhi in exercise of the powers conferred upon me under Regulation 21 of the Delhi Control of Vehicular and other Traffic on Roads and Streets Regulations, 1980, do hereby declare 'One-Way' for all type of vehicles on the road with entry from Munirka Marg (Priya Complex Road) adjacent to Hotel Vasant Continental to Vasant Lok Hospital Road and on the road behind Vasant Complex connecting Poorvi Marg with Vasant Lok Hospital Road, till further order.

This order shall be published for information of the general public in the Official Gazette and by affixing a copy on the Notice Boards of the offices of all Distt. DCsP and all Police Stations in Delhi/New Delhi.

The concerned civic agency and road maintaining authorities shall erect corresponding sign boards indicating, the 'One-Way' in the area for the information and convenience of all concerned.

This order shall come into force with immediate effect.

2. नियम 95-क का संशोधन :—दिल्ली मोटर वाहन नियमावली, 1993 के नियम 95-क के खंड (ख) को हटाया जाएगा।

## RULES

1. **Short title and commencement :—**(1) These rules may be called the Delhi Motor Vehicles (Third Amendment) Rules, 2004.

(2) They shall come into force on the date of their publication in the Delhi Gazette.

2. **Amendment of rule 95-A :—**In the Delhi Motor Vehicles Rules, 1993 in rule 95-A, clause (b) shall be omitted.
