**NOTIFICATION**

No. F.82/1161/RO/ESO(Disab.)/AD-III/DSW/2017 in exercise of the powers conferred by the proviso to article 309 of the Constitution, read with the Government of India, Ministry of Home Affairs Notification no. F.27/59-Him. (i) dated, the 13<sup>th</sup> July, 1959, the Lt. Governor of the National Capital Territory of Delhi with prior consultation with UPSC, is pleased to frame the Recruitment Rules to the posts of Rehabilitation Officer (for Persons with Disabilities) in Department of Social Welfare, Government of National Capital Territory of Delhi, as following namely:

1. Short title and commencement. – (1) These rules may be called the Department of Social Welfare, Rehabilitation Officer (for Persons with Disabilities), Recruitment Rules, 2020 (2) They shall come into force with effect from the date of their publication in the Delhi Gazette.
2. Number of posts, classification and scale of pay-The number of the said posts, their classification and the scale of pay attached thereto shall be as specified in column (2) to (4) of the Schedule annexed to these rules.
3. Method of recruitment, age-limit, qualification etc. – the method of recruitment to the said posts, age limit, qualifications and other matters connected therewith, shall be as specified in column (5) to (13) of the said schedule.
4. Disqualifications. – No person, -
  - (a) Who has entered into or contracted a marriage with a person having a spouse living or
  - (b) Who having a spouse living, has entered into or contracted a marriage with a person,

Shall be eligible for appointment to the said post:

Provided that the Government may, if satisfied that such marriage is permissible under the personal law applicable to such person and the other party to the marriage and that there are other grounds for so doing exempt any person from the operation of this rule.

5. Power to relax. – Where the Government is of the opinion that it is necessary of expedient so to do, it may, by order and for reasons to be recorded in writing and in consultation with UPSC, relax any of the provisions of these rules with respect to any class or category of persons.
6. Saving. – Nothing in these rules shall affect reservations, relaxation of age limit and other concessions required to be provided for the Scheduled Castes, the Scheduled Tribes, and other special categories of persons in accordance with the orders issued by the Central Government from time to time in this regard.

(ii) A degree level course registered with Rehabilitation Council of India in Psychology or Disability Administration and Rehabilitation or in any field of disability or Occupational Therapy or Physiotherapy.  <b>Experience:</b> 07 years practical working experience in welfare of PWDs in Physical/Vocational rehabilitation in institute/offices working for persons with special needs.  <b>Note 1:</b> Qualifications are relaxable at the discretion of the UPSC/Competent Authority in the case of candidates otherwise well qualified.  <b>Note 2:</b> The qualification(s) regarding experience is relaxable at the discretion of the UPSC/ Competent Authority in the case of candidates belonging to Scheduled Castes or Scheduled Tribes if at any stage of selection the UPSC/Competent Authority is of the opinion that sufficient number of candidates from these communities possessing the requisite experience are not likely to be available to fill up the vacancy reserved for them.  <b>Desirable:</b> (i) Ph.D or M.Phil in Disability Rehabilitation or in Clinical Psychology or Rehabilitation Psychology or Spl. Edu. Or Masters in Physiotherapy or Occupational Therapy.  (ii) Knowledge of Hindi.

9. (Period of probation, if any)	Two Years for direct recruits and promotees.
